### I. CHUS President Qiang Fang and Board's 2017 Annual Report (Presented at the CHUS Business Meeting at the 2018 AHA Annual Conference)

Dear CHUS Members and Friends,

Happy Chinese New Year! The CHUS Board wishes all of you and yours a very happy and productive year of 2018!

On January 6, 2018, the CHUS Board held its annual business meeting at the AHA conference in Washington D.C. The meeting started at 7pm and lasted until 9pm at Marriott Wardman Park. Dr. Qiang Fang chaired the meeting and presented the board by inviting Dr. Danke Li, CHUS Conference Coordinator, and Dr. Shuhua Fan, Editor of CHUS Newsletter and Web Manager, to give their annual reports to the members. Dr. Dandan Chen, CHUS Secretary, and Dr. Xiaojia Hou, CHUS Treasurer, could not attend the meeting, but sent their annual reports to Dr. Qiang Fang.

**Dr. Dandan Chen** reported that CHUS has an increase of members since last year. Thanks to Professors Xi Wang, Xiaobing Li, Qiang Fang and Xiansheng Tian, we have recruited several student members and members from mainland China. The Wechat group has gradually absorbed new members, shared cultural, social, academic news, and had discussions. (Special thanks to Professor Xiansheng Tian for keeping it very active). It is very nice that Dr. Xiaojia Hou, our treasurer, has opened her paypal account to accept CHUS membership fee. It makes payment easier for some overseas members. Another suggestion is to accept membership fee from wechat wallet (微信转账). It could make it even more convenient for scholars in mainland China to pay membership fees.

**Dr. Xiaojia Hou** reported that as of December 31, 2017, we have \$16,986 balance in total. The payments to Taylor & Francis and to the 2017 annual award plaque expenses have not been processed, so they will show up in the expenses for 2018. Dr. Hou also included a US Bank account and Paypal account. The Paypal account created by Dr. Hou will make it much easier for CHUS members outside the US to pay membership fee.

**Dr. Danke Li** reported about the CHUS panels for the 2017 and 2018 AHA annual conference DR. Li said that two high quality CHUS panels were included in the programs of the 2017 AHA annual conference held in Denver, CO. Both panels were well attended and received.

- 1. "In and beyond the Chinese Communities: The Rise of Civil Rights Consciousness and Activities as a Transnational Experience."
- 2. "Power, Law, and State Building in Republican China, 1912–1949."

In 2017, CHUS organized three high quality panels for the 2018 AHA annual conference that was held in Washington D.C. All three panels were well attended and received at the conference. The three panels are as follows:

1. "Legal Reforms, Philosophy, and Women in the Media in China during the Late Qing and Early Republican Period."

- 2. "Security, Trade, and Nationalism: Perception/Misperception and US-China Relations."
- 3. "Corruption and Anti-corruption in Modern China."

During the year of 2017, CHUS also participated in the AHA survey regarding affiliated societies, and Danke Li, the Conference Coordinator, attended meetings organized by the AHA for affiliated societies.

#### **Dr. Shuhua Fan** reported her work as follows:

The Main Work Done in 2017:

- 1. Edited the summer 2017 Issue CHUS newsletter.
- 2. Collecting data for the winter 2017 issue CHUS newsletter in mid-December, and editing the winter issue in February, 2018.
- 3. Updated CHUS group email list by cooperating with other board members.
- 4. Updated CHUS website.

#### Plans for 2018:

- 1. To edit the summer and winter 2018 issues of the CHUS newsletter.
- 2. To keep updating CHUS group email list.
- 3. To make efforts to maintain CHUS website and keep it up-to-date.
- 4. To help promote and publicize CHUS-sponsored events at CHUS website and in the newsletter as well as through other ways.
- 5. To cooperate with CHUS President and other board members in all matters to make CHUS better.

**Dr. Qiang Fang** reported that in the past year, while the proposed jointed conference with Jinan University could not be held as planned, the CHUS has several exciting news to share with CHUS members.

**New Members**: As Dr. Dandan Chen has reported, the CHUS has added many new members with the help of professors Xi Wang and other CHUS members.

**Taiwan Trip**: The CHUS organized a trip to Taiwan sponsored by the Grand Alliance and its president, professor Ge Yongguang. The trip that lasted twelve days from May 28<sup>th</sup> to June 9<sup>th</sup>. Nine CHUS members joined the trip. During the tour, CHUS members visited such famous museums as the National Palace Museum, Sun Yat-sen and Chiang Kai-shek Memorials. The delegation also met with many Taiwan political and business leaders, including, among other leaders, GMD vice president Hu Zhiqiang, and former president Ma Ying-jeou, to consult useful materials for a book on corruption and anticorruption in modern China that is currently edited by Drs. Qiang Fang and Xiaobing Li.

**Macau Conference**: Thanks to the important and generous support of the History Department at the University of Macau, especially Professor Di Wang, Chair of the Department, CHUS will jointly sponsor a conference entitled "Imagined Communities: Links between China's Past, Present, and Future." The Call for Papers was announced on July 1<sup>st</sup>. After the deadline ended on the New Years day of 2018, there were a total of forty-three proposals. In the following week, despite the official close of the submission, we continued to receive proposals from CHUS

members. Now the total number of proposals is forty-seven. More importantly, some of the proposals came from historians (most of them based in China) who are not CHUS members, so this proposed conference may serve as a channel to help CHUS recruit more members from Chinese institutions. We are very grateful to Professor Di Wang and the History Department at the University of Macau for making the arrangements for the joint conference.

Anti-corruption Book: During the 2017 trip to Taiwan, Dr. Xiaobing Li, former CHUS president, and Dr. Qiang Fang come up with the idea to edit a book on corruption and anticorruption in modern China. The idea looked very attractive to most of the CHUS members in the delegation to Taiwan, and won their support. After meeting with a number of GMD leaders, Dr. Qiang Fang and Dr. Xiaobing Li began inviting CHUS members to contribute chapters, and drafted a book proposal. By now, most contributors have completed their chapters and the book manuscript will be ready for submission in March, 2018.

"China in the New Era" Book Series: The Amsterdam University Press, a premium press based in the Netherlands, has launched a new book series titled "China in the New Era." The new book series aims to showcase fine scholarly research on a variety of topics such as politics, diplomacy, law, gender, military, and the like in the People's Republic of China. Studies of Taiwan around the same period or the Republic of China are also welcome. CHUS members and friends are especially encouraged to submit their unpublished manuscripts to Dr. Qiang Fang (qfang@d.umn.edu), the series editor.

Creating a Graduate Student Paper Prize: During the CHUS business meeting at the 2018 AHA conference, Dr. Tao Wang and a couple of others suggested that the CHUS, like other organizations, create a graduate student paper prize that will both recognize the work of promising young historians and also encourage graduate students to do research. The CHUS board will discuss this excellent idea in the coming months. If everything goes smoothly, the CHUS will establish a committee for this paper prize.

Looking ahead, the CHUS will have another important year in 2018. Not only will many old and new CHUS members attend the Macau conference, but the CHUS will also need to nominate and elect a new president and a new board to lead the organization in the next two years from 2019 to 2021.

#### CHUS Annual Awards: Reported by Drs. Patrick Shan, Yi Sun, and Xiaoping Cong:

**The Distinguished Service Award Committee,** including Drs. Ping Yao, Mao Lin and Patrick Fuliang Shan (chair), was organized in the summer of 2017 by the CHUS Board. After the callfor-nominations was sent out, the committee received several nominations. The committee deliberated over the candidacies of the nominees, and recommended that the CHUS Board bestow this year's award to two co-winners: Drs. Danke Li and Xiaoping Cong.

<u>Professor Danke Li</u>, a faculty teaching Chinese history at Fairfield University in Connecticut, has been a member of the CHUS Board for three terms. During her tenure as the board member, she has worked diligently as the conference organizer. In this role, she has worked effectively with the American Historical Association (AHA) conference coordinators to retrieve relevant

information. She has always sent out calls for panels and papers to CHUS members in a timely manner. She has collected information of panels, including abstracts, and inserted all relevant information manually into the AHA system. This is a tedious job, as it might take a week or so to insert all information by hand. Any minor errors might cause issues, which might lead to rejection by the AHA. In the past years, all CHUS panels under her management were accepted without any issues, which guaranteed the smooth and successful operations of the CHUS as a national scholarly organization. She has also served as a panel chair or a discussant. In addition, she has always offered her valuable services to the CHUS and its members whenever she is needed.

<u>Professor Xiaoping Cong</u>, a faculty teaching Chinese history at the University of Houston, Texas, served as the CHUS president between 2011 and 2013. During her tenure as the leader of this organization, Dr. Cong worked diligently. She conducted reforms and created new venues for the routine operations of the CHUS. Furthermore, she updated the CHUS website by building a new server, and endeavored to reach out for public support for the CHUS. More importantly, she launched a fund-raising campaign, and amazingly obtained a few donations, amounting to more than four thousand dollars from outside donors, which enormously improved the CHUS' financial situation. During her presidency, Dr. Cong did her best to support the CHUS journal, *The Chinse Historical Review*, and her efforts guaranteed the timely publication of the journal. She has also served as the chair or a member of various CHUS committees, and has been an active participant of other CHUS activities.

The Academic Excellence Award Committee was organized and reorganized in the summer of 2017, with Dr. Yi Sun as the chair and Drs. Pingchao Zhu and Xiansheng Tian as members. After call for nominations, the committee deliberated over the quality of scholarly works, and recommended that CHUS bestow the award to <u>Dr. Xiaobing Li</u> for his monograph entitled *The Cold War in East Asia* (Routledge, 2017).

<u>Dr. Xiaoping Li</u> is the most prolific writer among CHUS members, having authored or coauthored eighteen books and edited volumes. These publications deal with a wide variety of subject areas, encompassing military, diplomatic, political, social, and cultural histories. Indeed, Dr. Li has done CHUS proud with his phenomenal scholarly accomplishments as well as his instrumental service to the organization.

To add one more golden leaf to his laurels, Dr. Li published another book in 2017, entitled *The Cold War in East Asia*, by the prominent publisher Routledge. This book places East Asia, including China, Japan, and the two Koreas, at the center stage of the Cold War from 1945 to 1991. While many conventional texts have taken a Euro-American centric approach, characterizing the Cold War as a confrontation between the United States and the (former) Soviet Union that led two contending camps in the post-WWII world -- the "free world" and the communist/socialist block, East Asia in comparison has received less scholarly attention, partially due to cultural and linguistic barriers and the lack of readily available sources for Western researchers. While some monographs have focused on Sino-American relations, Japan-U.S. relations and the Korean War during the Cold War years, East Asia as a whole remains, by

and large, in the periphery in the systemic and comprehensive analysis of the Cold War in its global context.

Dr. Li's book can also serve as a survey text with its coverage of the different interpretations of the origins and developments of the Cold War in East Asia. It explores new historiographical, thematic, and topical trends in the history of modern East Asia. Told with an emphasis on East Asian views, it explains how China, Japan, and the two Koreas have played a distinctive and instrumental role in shaping the historical contours of the Cold War. Dr. Li argues that, more than an ideological battle between capitalism and communism, the Cold War in East Asia was also a struggle between different political, economic, social, and cultural determinations and resolutions. Significantly, East Asian countries molded the Cold War through their own adaptation and transformation, evidenced in their cultural resilience in the face of new economic, military, and political challenges, both domestic and international. It demonstrates how East Asian countries utilized the global Cold War politics and economy to craft their own particular versions of survival, struggle, and success in decolonization, independence, industrialization, and modernization through the second half of the twentieth century.

Dr. Li's book also offers important resources for future research in Cold War studies, and opens new areas for Asian Studies courses. Scholars and students will find the book's primary sources, many of which are not readily available in English, of great interest, and they will also discover many intriguing issues that have been previously overlooked. In light of the merits and strengths of this book, we recommend *The Cold War in East Asia* for the 2017 CHUS Scholarly Achievement award in strongest possible terms.

**The Graduate Student Travel Grant:** Dr. Xiaoping Cong, chair of the committee, reported that there was no applicant from graduate students for this travel grant in 2017.

  - For Interested CHUS Members and Friends: "China in the New Era Series" is launched by AUP to meet the rising influence of the people's Republic of China (PRC) as

an economic, military, and political power in the world arena. Forty years after the Chinese Communist Party kicked off the reform, the PRC is now poised to surpass the United States as the world's greatest economy. A more confident and powerful PRC, coupled with increasingly rich primary sources, has drawn tremendous interest from scholars around the world. The primary focus of this series will be the PRC in the new era with kind of dual attention to earlier pertinent periods in the ROC and Late Qing. This series invites studies from a wide variety of disciplines and topics in politics, law, history, diplomacy, gender, and the like. Studies on modern history of greater China (e.g., Taiwan, Hong Kong) are also welcome.

- **Book Proposals**: A book proposal should be no more than 4000 words in length, which needs to include the following information:
  - 1. Tentative book title
  - 2. Name of author(s) or editor(s)
  - 3. Tentative table of contents (including a full list of authors or contributors if it is an edited volume)
  - 4. Rationales for and main contributions of the proposal
  - 5. Methodologies to be used
  - 6. How does this proposed manuscript fit within the "China in the New Era" Series
  - 7. Target audience
  - 8. Short biography of author(s)/editor(s)
  - 9. Estimated completing time of the manuscript
- **Book Manuscript**: A book manuscript should be between 200 and 300 pages in length. All book manuscripts will be reviewed first by series editorial board and then by peers.

- Press was established in 1992 by the University of Amsterdam, and is based on the Anglo-American publishing model. AUP has since then built up a publishing list of more than 1600 titles. 
#### **VIII. CHUS Member News**


**Dr. Chen, Li**, Associate Professor of History and Global Asia Studies, Chair of Department of Historical and Cultural Studies (UTSC) and Department of History (Graduate), University of Toronto, the Founding President of the International Society for Chinese Law and History (2014-17), and a Ph. D. from Columbia University, has exciting news to share with fellow CHUS members. Professor Chen's book, *Chinese Law in Imperial Eyes: Sovereignty, Justice, and Transcultural Politics* (Columbia, 2016), has been awarded the Joseph Levenson Pre-1900 Book Prize for 2018 by the Association for Asian Studies, and earlier won Honorable Mention for the American Society for Legal History's 2017 Peter Gonville Stein Book Award (presented for the best book in legal history written in English that focuses on all non-US regions, as well as global and international history). Published by Columbia University Press, the book uses a wide array of sources to examine the power dynamics of Sino-Western relations during the formative

century before the First Opium War (1839-1842). It highlights the centrality of law to modern imperial ideology and politics, and brings new insights to the origins of comparative Chinese law in the West, the First Opium War, and foreign extraterritoriality in China.

**Dr. Cong, Xiaoping**, Professor of History at University of Houston, has been promoted to full professor, starting from September 2017. Besides, Dr. Cong has published an article: "From Literati to Modern Teachers: The Identity Transformation of the Educated Elites in Early 20th Century China," *The Chinese Historical Review* 24: 2 (Nov. 2017): 146-65.

**Dr. Fan, Shuhua,** Associate Professor of History and Asian Studies at the University of Scranton, has been reappointed by Governor Tom Wolf for a second term (Nov. 2017-Nov. 2019) at the PA Governor's Advisory Commission on Asian-American Affairs. In addition, the Chinese edition of Dr. Fan's English book entitled *The Harvard-Yenching Institute and Cultural Engineering: Remaking the Humanities in China, 1924-1951* (Lexington Books, Aug. 2014) was published by Peking University Press in Nov. 2017 after some delay due to slow process of proofreading. Dr. Elizabeth Perry, Director of the Harvard-Yenching Institute and Henry Rosovsky Professor of Government at Harvard University, has written a preface for the Chinese edition. 





